- 3. The APFA Annual Convention shall be scheduled for five (5) days plus two (2) days travel.
- 4. Complimentary dinners for the Annual Banquet shall be limited to members who are being honored with awards for that year only. Complimentary dinners may be extended to guest speakers and sponsors at the diamond and emerald levels.
- 5. The Secretary shall be permitted a maximum of 2 assistance to attend.
- 6. The official photograph shall be the APFA Board of Directors and Ad Hocs only.
- 7. This policy shall be placed in the APFA Policy Manual Section 4.B.2.
