**WHEREAS**, long-standing policy of the APFA had been to require the approval of three (3) National Officers prior to the publication and or dissemination of *Skyword*, the APFA HotLine, the APFA Website and Official Press Releases of the APFA; and

**WHEREAS**, at the Special Meeting of the APFA Board of Directors of July 26 - 27, 2004, this policy was altered in preference of granting the President, and in limited instance one other Officer, sole authority of these mediums of communication; and

**WHEREAS**, after further consideration of this policy, the Board of Directors considers it preferable to return to the previous approval policies as established in the APFA Policy Manual whereby all official communication form the APFA, were approved by three (3) National Officers.

**THEREFORE BE IT RESOLVED**, that consistent with the above, all official communication from the APFA, including *Skyword*, *Skyword Express*, the APFA HotLine, the APFA Website and Official Press Releases of the APFA, must be approved by three (3) National Officers.

**BE IT FURTHER RESOLVED**, that the APFA Secretary is directed to issue a revision to the APFA Policy Manual consistent with the policies established herein.
