**WHEREAS**, flight attendants who choose to commute are not reimbursed by the company for expenses associated with commuting; and

WHEREAS, base representatives should be held to the same standard;

**BE IT THEREFORE RESOLVED**, that Article 5.F.1.a. of the APFA Policy Manual be amended to read:

All members shall be entitled to an APFA Meal Expense Allowance (MEA) when performing work for the APFA when away from their residence for one (1) or more nights at the Domestic Per Diem rate agreed to in the APFA/AA Collective Bargaining Agreement (For each hour they are away from residence) except that the above shall not apply to APFA base representatives performing base work at their home base.

**BE IT FURTHER RESOVLED,** that Article 5.G.4.a. of the APFA Policy Manual be amended to read:

Any member shall be reimbursed for lodging expenses incurred when required to remain overnight at a place other than his/her place of residence to conduct authorized APFA business. Prior approval must be obtained if direct billing of the hotel is requested except that lodging expenses will not be reimbursed for base representatives performing base work while at their home base.
