WHEREAS, Article III, 2.A. of the APFA Constitution vests the governmental powers of the APFA in the Board of Directors, and

WHEREAS, Article III, Section 3.L. (1) of the APFA Constitution states, in part, that the APFA Board of Directors sets policy for the APFA, and

WHEREAS, effective communication with the APFA membership is fundamental to the successful achievement of the objectives of the APFA established in Article 1 of the APFA Constitution, and

WHEREAS, Base Brief communications often contain time sensitive information that is very important to distribute to flight attendants as quickly a possible, and

WHEREAS, the current approval process outlined in Section 12.G.4. and 12.G.5 of the APFA Policy Manual states:

- 4. Before printing, Base Briefs must be approved by two (2) members of the Executive Committee, one of whom must be a National Officer.
- 5. All Scheduling information in the Base Briefs must be approved by the National Scheduling Coordinator.

BE IT THEREFORE RESOLVED, that Section 12.G.5. of the APFA Policy Manual be amended to read:

5. All Scheduling, Contract, Hotel, Safety& Security, Health, and Communication information contained in Base Briefs **must** be approved by the National Coordinator(s) or designee or the respective department(s).

BE IT FURTHER RESOLVED, Section 12.G.6 of the APFA Policy Manual is amended to read:

6. The approval process shall be accomplished in no longer than five (5) business days from the date received.

BE IT FURTHER RESOLVED, Section 12.G.7. and Section 12.G.8. read as follows:

- 7. An attempt should be made to publish at least four (4) Base Briefs per year.
- 8. Base Briefs shall be distributed via Board Packets no later than the first available Board Packet mailing after distribution to the flight attendants at the affected base(s).
