**WHEREAS**, the APFA Board of Directors unanimously passed Resolution #8 at the APFA Annual Convention, February 8-13, 2007; and

APFA Board of Directors Annual Convention January 4, 2008 Resolution # 3 Page Two

**WHEREAS**, Resolution #8 required APFA President Tommie Hutto-Blake, to obtain Board approval on any agreement regarding recalls and/or extension of recall rights; and

**WHEREAS,** on November 1, 2007, APFA President Tommie Hutto-Blake signed a Letter of Agreement without Board approval regarding a 2-month extension of recall rights to furloughed Flight Attendants scheduled to fall off the seniority list on November 1, 2007 and was therefore in violation of Resolution #8 of the February 8-13, 2007 APFA Annual Convention; and,

**WHEREAS,** APFA President Tommie Hutto-Blake was advised by the APFA Board of Directors at the Board Briefing on November 7, 2007, that any agreement reached regarding any extension of recall rights would be reviewed by the Board of Directors prior to approval; and

**WHEREAS,** President Tommie Hutto-Blake signed a Letter of Agreement regarding the 2-year extension of recall rights, dated December 20, 2007 and entered into a final and binding agreement with American Airlines and was therefore in violation of Resolution #8 of the February 8-13, 2007 APFA Annual Convention.

**BE IT THEREFORE RESOLVED,** for the remainder of the Presidential term ending March 31, 2008, APFA President Tommie Hutto-Blake shall not enter into any agreement with the company, such as, but not limited to Letters of Agreement and/or Letters of Understanding; and

**BE IT FURTHER RESOLVED,** that any Letters of Agreement and/or Letters of Understanding from the President's office or any agent of the President's office are subject to prior approval by the APFA Board of Directors.
