**WHEREAS**, the Board of Directors has the authority to modify the APFA Policy Manual.

**BE IT THEREFORE RESOLVED**, that Section 14.F.1 shall be modified to read as follows and the remainder of Section 14.F shall be deleted:

## INDEPENDENT BALLOTING AGENCIES

1. The NBC shall select two (2) outside independent balloting agencies to conduct the election of National Officers, Base Chair/Delegates and Vice Chair/Delegates, as well as referenda balloting. One (1) agency shall be for mail ballot elections/referenda, the other for electronic ballot elections/referenda.

**BE IT FURTHER RESOLVED**, that the NBC shall present to the Executive Committee at its next quarterly meeting, for its review and recommendation to the Board of Directors, a proposed revision of Section 14 of the APFA Policy Manual to incorporate electronic ballot provisions; and

**BE IT FURTHER RESOLVED**, that pending that revision of the APFA Policy Manual, the NBC may conduct elections/referenda by electronic ballot.
