WHEREAS, APFA Representatives/Volunteers who assist at APFA HDQ have possible exposure to confidential information and are required to sign the Code of Confidentiality; and

WHEREAS, their signing the Code of Confidentiality does not entitle these individuals to inclusion for off record discussions during BOD/EC Meetings, which require being "under the Code of Confidentiality".

THEREFORE BE IT RESOLVED, that the APFA Policy Manual Section 4.A be amended to add a new subparagraph 12:

12. Off-Record Discussions

- a. During off-record discussions of the Board of Directors and the Executive Committee, those entitled to be present are National Officers, Chairperson, Vice Chairpersons, Ad Hocs, National Coordinators, and Division Representatives, so long as each has signed the APFA Code of Confidentiality.
- b. When deemed necessary, the Board of Directors or the Executive Committee may, by majority vote or show of hands, allow other members who have signed the Code of confidentiality to be present for off-record discussions.
