WHEREAS, it is equally important that the System Board of Adjustment have a representative on the Joint Scheduling Committee (JSC) for purposes of monitoring issues going forward in the Article 29 – Systems Board of Adjustments process.

BE IT THEREFORE RESOLVED, that the following language be included in the APFA Policy Manual as Section 13.B.1.h.(1).(b):

- (b) The Joint Scheduling Committee shall be comprised of the National Scheduling Coordinator and six (6) National Representatives. The National Representatives shall include one (1) representative from each of the five (5) regions and one (1) representative from the System Board of Adjustment. The (5) regions are as follows:

 Northeast Region Boston, New York, Washington, D.C.; Southeast Region Raleigh, Miami; Western Region Los Angeles, San Francisco, St. Louis; Dallas Region; Chicago Region; Appointments to this committee require that:
 - 1. Each representative is listed as a current Base Council Representative of the national department, or is from the membership at large, and will bring to the committee knowledge, expertise, experience and/or aptitude.
 - 2. Each Regional Representative is recommended by the National Scheduling Coordinator and approved by the President.
 - 4. The System Board of Adjustment representative is appointed by the Vice President.

BE IT FURTHER RESOLVED, that Section 13.B.1.h (1)(a) of the APFA Policy Manual be amended as follows:

(c) All APFA national committees established pursuant to paragraph A. above, with the exception of the Joint Scheduling Committee, shall be comprised of the National Coordinator and five (5) national representatives. The national representatives should include at least two (2) from the domestic and two (2) from the international Operation, provided that each representative:
