WHEREAS, Article III, Sections 3.L(1) and (2) of the APFA Constitution authorize the Board of Directors to set policy for the APFA and to review, and if necessary, modify the APFA Policy Manual; and

WHEREAS, the Board of Directors recognizes the need for Base Chairs, Vice Chairs and other designated APFA representatives to have cellular/mobile phones to conduct APFA business; and

WHEREAS, the Board of Directors also has an obligation to use APFA resources prudently;

BE IT THEREFORE RESOLVED, that a new subsection [c] be added to Section 5.G.1(g)[3] of the APFA Policy Manual:

For purposes of cellular/mobile telephone expense reimbursement under this subsection, the term "total bill" includes data-related expense fees, but does not include late charges, ring tone charges, games charges, international calling plans for those who are not APFA representatives but are part of a shared plan, or any charges not necessary for conducting APFA business.

BE IT FURTHER RESOLVED, that the caption of Section 5.G.1(g)[4] be corrected to be "Release of Liability."
