WHEREAS, the APFA Board of Directors is the governing body of the APFA; and

**WHEREAS,** Article III, Section 3.L.(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, if necessary, modify the APFA Policy Manual; and

WHEREAS, per Art.III.I.2. in the absence of the Chair.....the Vice Chair shall perform the duties of the Chair, and those duties may consist of assuming the seat of the Chair when the Chair has been called away, or otherwise must leave a portion or all of the meeting/convention

of the BOD; and

**WHEREAS**, base representative's budgets are based on the headcount at their base, and trip removals for Vice Chairs of bases with more than 500 Flight Attendants at their base are taken from the base budget; and

**WHEREAS**, base budget constraints continue to create a hardship when Vice Chairs are attempting to attend meetings/briefings of the BOD;

**BE IT THEREFORE RESOLVED,** Section 4.A.9.b. of the APFA Policy Manual be amended to reflect the following modification:

b. The Vice Chair will be encouraged to attend all Board of Directors meetings. Trip removals for the Vice Chair of bases with less than 750 Flight Attendants at their base will be taken from the Board of Directors budget.
