WHEREAS, Article III, Section 3.L.(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, if necessary, modify the APFA Policy Manual; and,

WHEREAS, Section 13.B.1.e.(1)a states that the *“Safety / Security Coordinator will coordinate with base representatives to monitor Company practice and compliance with respect to aircraft, crew, passenger and cabin safety and Company safety procedures; and”*

WHEREAS, over the years, we have seen “Natural Disasters”, such as hurricanes, tornados, earthquakes, tsunamis, etc. devastate our members residing or laying-over in the affected areas and cause severe damage to the base operation;

THEREFORE BE IT RESOLVED, the above mentioned policy manual section be amended to include “Natural Disaster” as an issue that may require support from APFA on a National level.

BE IT FURTHER RESOLVED, the language provided below, will replace the current language/ be added to Section 13 of the APFA Policy Manual.

Amend:

Section 13.B.1.e.(1)(a) states that the “*Safety / Security Coordinator will coordinate with base representatives to monitor Company practice and compliance with respect to aircraft, crew, passenger and cabin safety, **natural disasters**, and Company safety procedures; and*

Add:

Section 13.B.1.e.(1)(a)[6] *coordinate with Base Representatives to organize a method of response by the APFA in the event of a natural disaster, so as to provide assistance for Flight Attendants/Base Representatives in the affected areas.*
