WHEREAS, Article II, Section L.1 of the APFA Constitution states that the Board of Directors shall “set policy for the APFA;” and

WHEREAS, Section 5 C.3. of the APFA Policy Manual does not specifically address trip removals encompassing federal holidays and critical periods; and

WHEREAS, trip removals authorized during the critical holiday periods have a negative impact on our members serving reserve, and could result in reassignments of regularly scheduled flight attendants during such critical period.

BE IT THEREFORE RESOLVED, that except in cases of emergency, during the critical holiday period, no trip removals shall be authorized for any APFA representatives unless the trip was on the representatives original schedule. The critical holidays are defined as: Christmas Day, New Years' Day, Memorial Day, July 4th, Labor Day and Thanksgiving Day.

The APFA Policy Manual shall be updated to reflect the change as Section 5.C.3.d.
