WHEREAS, the APFA Board of Directors is the governing body of the APFA; and

**WHEREAS**, Article III, Section 3.L.(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, if necessary, modify the APFA Policy Manual; and

WHEREAS, a National Officer can choose to retire with or without A5 passes; and

**WHEREAS**, such a benefit is not afforded to our membership upon retirement.

**BE IT THEREFORE RESOLVED**, if any National Officer(s) chooses to accept A5 travel passes as a retirement benefit, the National Officer must retire before their term expires.

**BE IT FURTHER RESOLVED**, that if the National Officer accepts the A5 travel pass benefits, they also forfeit the transition period afforded to them at the end of the term.

**BE IT FURTHER RESOLVED**, that Section 6.B.6.b.(1) of the APFA Policy Manual, be changed immediately to read as follows:

(1) At the end of a term or consecutive terms, National Officers will be provided with a one (1) month transition period; provided that they don't accept A5 travel passes as a retirement benefit.

**BE IT FURTHER RESSOLVED,** if any question(s) arise to the intent or interpretation of this resolution, it will be brought to the Board of Directors for clarification.
