WHEREAS, a resolution was written to encourage Union Reps with a full month removal to paperbid; and

WHEREAS, resolution number 11, dated June 20, 2007 was written to provide a means for recovering incentive pay which was lost when picking up an optional exchange; and

WHEREAS, a representative on a full month paperbid would not have the ability to attain a trip at incentive rates; and

WHEREAS, a representative who does not paperbid will have the ability to pick up time at incentive rates.

THEREFORE BE IT RESOLVED, that the language in Section 5 of the Policy Manual be clarified and modified to represent the original intention of Resolution 11 dated June 20, 2007 so that those representatives who are entitled to a full time removal and choose to paperbid for a full month will be reimbursed the incentive pay lost for OEs; and

BE IT FURTHER RESOLVED, those representatives who do not paperbid the entire month or those representatives who are not entitled to a full month removal will not be entitled to this reimbursement.
