0914 Call to Order – President's Opening Remarks

President Laura Glading called the Special Board of Directors' Meeting to order. President Glading reiterated the difficulty of the current situation and requested that everyone stay focused on APFA's goal.

0927 Roll Call

The roll was taken by Secretary Denise Pointer. All members of the Board of Directors were present with the exception of Vice President Durkin who was scheduled to join the meeting later in the morning.

0928 Agenda Review and Approval

A motion was made to approve the agenda as presented. At this time amendments and additions were requested.

0938 Bankruptcy Review

President Glading spoke to the meeting held on February 1st at Flagship University. She outlined the format of the meeting as well as the information presented. President Glading discussed the individual meetings held with each union where AA presented their "term sheets".

President Glading has had several discussions with the PBGC in Washington, D.C. The PBGC is encouraging American Airlines to continue the pension programs and is very supportive of all unions on property at American Airlines. She also reported that she has met with the new acting administrator of the FAA who is also supportive of the AA Flight Attendants.

Julie Frederick, APFA Legislative Affairs Representative, spoke regarding a letter being circulated by Rep. Pete Sessions of North Texas encouraging Congress to allow American Airlines to turn over its pension obligations to the PBGC. APFA has authored a letter to be sent by Congressman George Miller stating that American Airlines should honor its pension obligations. Representative Miller was the Chairman of the Pension Subcommittee and is now the ranking Democrat on the committee

President Glading proceeded to take the Special Board Meeting off the record for additional bankruptcy presentations by APFA's team of bankruptcy professionals.
