WHEREAS, Article III, Sections 3.L(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, and if necessary, modify the APFA Policy Manual;

BE IT THEREFORE RESOLVED, that the following changes be made to the Policy Manual:

BOARD OF DIRECTORS MEETING

1. Section 12.D shall be modified to read:

1. **HOTLINE**

1. The APFA will establish an electronically-distributed “HOTLINE” message for the benefit and information of Flight Attendants.
2. HOTLINE text and distribution will be the responsibility of the Communications Coordinator, except as otherwise provided in this Policy Manual.
3. The HOTLINE should provide a weekly update of APFA and industry news.
4. Balloting results will be announced on the HOTLINE by the APFA Secretary or his / her designee, who should be a member of the National Balloting Committee (NBC), as soon as the information becomes available.
5. With the exception of balloting results, HOTLINE text must be approved by a majority of the National Officers prior to distribution.

2. Section 13.B.1.a.(4)(b) shall be modified to read:

Ensure that the HOTLINE is distributed on a regular basis, at least one per week, or as otherwise directed by the President.
