WHEREAS, Article III, Section 3.L (1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review and if necessary, modify the APFA Policy Manual; and

WHEREAS, Section 5.C.1.a. (1) of the APFA Policy Manual states "Any member in good standing may be removed from flying assignment(s) to participate in the affairs of the APFA"; and

WHEREAS, such member is also "encourage to fly and should attempt to fly a minimum of one (1) trip every rolling six (6) month period"; and

WHEREAS, in order to comply with the above, the APFA member has to possess up-to -date line qualifications;

THEREFORE BE IT RESOLVED, that section 5 of the APFA Policy Manual be amended as follows:

5. C.1

a. Any member in good standing elected or appointed to an official position is encouraged to retain up-to -date line qualifications, subject to the provisions herein.

BE IT FURTHER RESOLVED, that section 6.E be added to the APFA Policy Manual:

E. LINE QUALIFICATIONS

1. Any member in good standing elected or appointed to an official position is encouraged to retain up-to -date line qualifications, subject to the provisions herein.
