**WHEREAS**, Article III, Section 3.L.(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, if necessary, modify the APFA Policy Manual; and

**WHEREAS**, APFA has a responsibility to operate in a fully transparent environment and to ensure that the membership dues is being spent to operate an efficient and effective organization; and

**WHEREAS**, the membership should be able to clearly find the organizational structure and various individuals working for the membership; and

**WHEREAS**, it is confusing to locate various committees, etc via the APFA.org website

**THEREFORE BE IT RESOLVED**, that Section 13.A.4-5 be added to read:

4. Two organizational charts incorporating all Administrative Departments, Committees, Chairs and Regional Representatives will be created and posted on the APFA.org website under the tab entitled Departments. One chart will have a high level view (who elects, appoints, etc) and the other chart will have actual names of the individuals in those respective positions. The website will be updated at least monthly with any changes. This will include any future or newly created positions, committees, chairs that would fall within or be defined in Section 13 (the section defining all such positions) of the APFA Policy Manual.

5. Each National Officer, National Chair of an Administrative Department, or any Chair of a National Committee must place on their respective APFA.org webpage, their departmental structure and list the names of any FAs that work for that department or committee.
