WHEREAS, the APFA Board of Directors is the governing body of the APFA; and

WHEREAS, Article III, Section 3.L.(1) and (2) of the APFA Constitution authorizes the Board of Directors to set policy for the APFA and to review, if necessary, modify the APFA Policy Manual; and

WHEREAS, certain portions of the Policy Manual need to be updated or revised;

THEREFORE BE IT RESOLVED, that 5.C.8.a (2) of the APFA Policy Manual be modified to read;

- a. Full month trip removal, as defined in Section 1.A.7. of this Policy Manual is authorized for:
- (2) Base Representatives with headcounts of at least seven hundred fifty (750) Flight Attendants:
 - (a) A minimum of one (1) full month trip removal authorized for each seven hundred fifty (750) Flight Attendants.
 - (b) Any portion above seven hundred fifty (750) will be prorated on a per capita basis.

(c) Representatives at bases with headcounts less than 750 shall be budgeted with one full trip removal.

Delete:

5.C.9 Base Representatives authorized for less than full month trip removals

5.C.10 Seven (7) Day Trip Removal Provision
