**WHEREAS**, at that time we will not be in compliance with the APFA Constitution; and

**WHEREAS**, on April 1, 2017 Jennifer Welpott will become the SFO Base President; and

**WHEREAS**, appointing her to the Budget Committee will satisfy the requirement of the APFA Constitution.

**BE IT THEREFORE RESOLVED**, that effective April 1, 2017 Kimberly Smedley is removed from the Budget Committee; and

**BE IT FURTHER RESOLVED**, that effective April 1, 2017 Jennifer Welpott is appointed to the Budget Committee as the voting member of the Board of Directors for the remainder of the two year term ending March 31, 2018.
