WHEREAS, training is currently provided to the Regional Representatives specific to Arbitration/Case Preparation; and

WHEREAS, an additional training specific to their duties as a Grievance Review Committee and determining the merits of a case or if a case is adverse, would be beneficial for new Regional Representatives at the beginning of their term;

THEREFORE BE IT RESOLVED, an additional requirement of Grievance Review Committee Training shall be included in the current training for the Regional Representatives at the beginning of each term; and,

BE IT FURTHER RESOLVED, for the current term, this training be provided within the next 45 days.
