**WHEREAS**, the governmental powers of the APFA shall be vested in the Board of Directors, and the officers and representatives of the APFA in accordance with the provisions of the Constitution; and,

**WHEREAS**, on September 11, 2001 a two American Airlines aircraft were hijacked and used as weapons of mass destruction crashing into the North Tower of the World Trade Center in New York City and the Pentagon in Washington DC; and,

**WHEREAS**, thirteen APFA represented American Airlines Flight Attendants gave their lives as the ultimate sacrifice in the line of duty, and,

**WHEREAS**, Article III, Section 6 of the APFA Constitution outlines and defines the duties and responsibilities of the National Officers of the APFA; and,

**WHEREAS,** Article III, Section 6, B, (1) states that "The National President shall be the chief executive officer of the APFA, and shall conduct the affairs of the APFA in accordance with this Constitution and the resolutions and policy decisions of the Board of Directors and/or the Executive Committee."; and,

**WHEREAS,** Article III, Section 6, C, (1) states that "The National Vice President shall assist the National President in the discharge of all duties...]"

**THEREFORE BE IT RESOLVED** that the Board of Directors of the APFA hereby decree that the APFA National President and/or the APFA National Vice President shall make every effort to represent the APFA's members at any public memorial service that takes place at New York City and/or Washington DC by attending such services.
