**WHEREAS,** Article III, Sections 3.L(1) and (2) of the APFA Constitution authorize the APFA Board of Directors to set policy for APFA and to modify the APFA Policy Manual as it deems appropriate; and

**WHEREAS**, the current provisions of the APFA Policy Manual concerning disposition of furniture of outgoing National Officers or Representatives are in need of updating;

**THEREFORE BE IT RESOLVED,** that Section 5.H.7.of the APFA Policy Manual be amended to read:

- a. Furniture, furnishings /appliances / equipment in need of replacement shall be replaced as needed.
- b. Outgoing National Officers or Representatives shall have the option of purchasing at fair market value the furniture/ furnishings / appliances / equipment that were provided in their APFA accommodations.
- c. Any furniture / furnishings /appliances / equipment that is not purchased by an outgoing National Officer or Representative shall be sold through a consignment store. Any such items that are not sold within six (6) months of receipt by the consignment store shall be donated to charity.
