This letter will confirm our agreement with respect to Legacy US Airways Flight Attendants who are in their 6th Year of Service on the effective date of the new pay rates (1/1/15). The 6th year hourly rate under the Joint Collective Bargaining Agreement shall be \$36.25. The artificial pay rate of \$39.34, for the period from DOR to the date on which the Flight Attendant moves to the 7th Year hourly rate, shall apply to the following flight attendants:


