WHEREAS, the APFA Policy Manual authorizes reimbursement for cellular telephone and broadband (internet) service for Base Presidents, Base Vice Presidents, Executive Committee members, Department Chairs and Regional Representatives; and

WHEREAS, these individuals provide services to our membership both locally and nationally; and

WHEREAS, they rely on the use of cellular telephone and internet service to perform and accomplish their duties.

BE IT THEREFORE RESOLVED, that Section 5.G.1.e (1)(g)[1] be amended to include new (a):

(a) APFA Specialist or Live Chat representative (that works a minimum of 15 shifts in a month) shall be authorized to incur cellular telephone expenses not to exceed forty-five dollars (\$45) per month.

and

BE IT FURTHER RESOLVED, that Section 5.G.1.e (1)(b)[7] be amended to include new (a):

(a) A Base Council Representative (on a full month trip removal), Specialist and Live Chat Representative (that works a minimum of 15 shifts in a month) may be reimbursed for up to fifty dollars (\$50) of the monthly cost applied to one of the following types of broadband: DSL, cable, fiber or satellite.
