WHEREAS, APFA is in the process of forming a Negotiating Committee to negotiate a collective bargaining agreement once the current contract becomes amendable; and

WHEREAS, Article X, Section 5.A.(1).b. of the APFA Constitution provides that six (6) representatives, who shall be elected by the membership at large, who shall be appointed by the APFA National President, and who shall be appointed by the APFA Board of Directors by a two-thirds (2/3) affirmative vote of the voting Board of Directors; and

WHEREAS, two (2) Negotiating Committee members have been elected by the membership at large;
and

WHEREAS, four (4) members of the Negotiating Committee have yet to be appointed; and

WHEREAS, two (2) members of the Negotiating Committee will be appointed by the APFA National President and two (2) members of the Negotiating Committee will be appointed by the APFA Board of Directors.

BE IT THEREFORE RESOLVED, that the Board of Directors appoints Matt Foust and Brian Morgan as members of the Negotiating Committee.
