WHEREAS, under the APFA Constitution, the governmental powers of the APFA shall be vested in the Board of Directors: and

WHEREAS, Article III, Section 3.A., authorizes and empowers the Board of Directors to safeguard and protect the APFA and the rights, privileges, duties and responsibilities of the officers, representatives and members of the APFA; and

WHEREAS, Article III, Section 3.L.22., authorizes the Board of Directors to take any and all appropriate actions deemed necessary to promote the welfare of the members of the APFA; and

WHEREAS, Article III, Section 6.B.5, states in part the President shall oversee all other national committees, unless otherwise provided for in the Constitution or by resolution or policy of the Board of Directors; and

WHEREAS, the APFA Policy Manual, Section 13 states in part the National Departments are established by the Board of Directors to function in concert with the Flight Attendants, the Base Councils, the National Officers and the Executive Committee so as to foster communication, cooperation, strength and unity within the APFA; and

WHEREAS, recent events require intervention from the APFA Board of Directors.

THEREFORE BE IT RESOLVED, the APFA Board of Directors shall commit to working with the National Officers and the National Departments to build a better working relationship. The APFA Board of Directors role will be to offer any additional support needed.
