Griffiths Award pin and a written commemoration of the recognition of their contribution to the APFA shall be presented at the Annual Convention following the meeting at which the Board of Directors bestows the award; and

WHEREAS, in his 35 years as an American Airlines Flight Attendant, Patrick Hancock has been based at Dallas/Fort Worth; and

WHEREAS, during his career with APFA, Patrick has served in many capacities including, but not limited to, DFW Base Council Representative, an AdHoc Member of the Executive Committee, Base Retirement, Pension and Benefits Committee, National Retirement Specialist, Strike Captain and one of the Dallas 20; and

WHEREAS, in his long career as an APFA representative, Patrick has been a tireless advocate for Unionism and for the Membership;

WHEREAS, Patrick devotes his time and friendship to his colleagues, providing tremendous support and mentoring in their Union work and for the advancement of the Flight Attendant Profession;

BE IT THEREFORE RESOLVED, that the Martha W. Griffiths Award, APFA's highest honor, be presented to Patrick Hancock in recognition of his contribution to APFA at the 2020 convention.
