THEREFORE BE IT RESOLVED, that every effort be made to schedule meetings on one of the allotted 19 APFA days or to arrange coverage by other reps on trip removals, to reduce trip removals on extra pick up trips; and

BE IT FURTHER RESOLVED, that extra trip removals by any representative be approved only in an emergency or exigent basis to be determined by two National Officers.
