WHEREAS, the APFA National Officers are charged with acting in a prudent and fiduciarily sound manner to achieve the business and objectives of the APFA; and

WHEREAS, furniture and furnishings or appliances have been purchased for the above said apartments; and

APFA BOARD OF DIRECTORS MEETING

WHEREAS, such furniture and furnishings or appliances have a life and value to the APFA beyond the term of office of any officer or representative; and

WHEREAS, any furniture and furnishings or appliances purchased by the APFA are deemed property of the APFA.

BE IT THEREFORE RESOLVED, that the Board of Directors establish spending limits to be followed in the purchase of furnishings for use by incoming National Officers and other representatives covered by the APFA Policy Manual; and

BE IT FURTHER RESOLVED, that the initial purchase of furnishings shall be limited to seven thousand (\$7,000) dollars.
